

## NOTICE TO ALL PLAINTIFF ATTORNEYS

The perilous state of the Road Accident Fund's finances is a matter of public record and has been a subject of legal processes before courts in recent times. The Fund has implemented an equitable payment system where older claims are paid first, subject to the fulfilment of the Fund's requirements. In order to ensure that the payment system is functioning optimally, the Fund must ensure;

- (i) that all court orders, settlement agreements, offer acceptances, taxed bills/allocaturus etc. are loaded on its system for payment, and
- (ii) that a regular update of attorneys RNYP list (Requested not paid) is provided to plaintiff's attorneys.

In order to achieve the above, the Fund invites all plaintiff's attorneys whose claims have been settled, but have not been requested for payment, to submit a list of all such outstanding matters together with the necessary supporting documents to the following dedicated email addresses:
