- are not facing any application for suspension or striking off; and
- are not subject to any pending disciplinary complaint and/or proceedings relating to allegations
 of abuse of trust moneys;

The ADF's assistance will be granted at its sole discretion, and no applicant shall have any right to receive such assistance or any appeal against the failure of his/her application.
