# Amendment of Rule 2

# Rule 2: Application fees

[The following] <u>Application</u> fees (which are inclusive of value-added tax), <u>in the amounts prescribed by the Council</u> <u>from time to time, and as notified by the Council in the Gazette and on the Council's, website</u> shall be payable on application to the Council in respect of the matters referred to below:

# Amendment of Rule 3

### Rule 3: Annual fees for Fidelity Fund certificates

3.1 Every attorney required to be in possession of a Fidelity Fund certificate, and every advocate contemplated in section 34(2)(b) of the Act, shall pay to the Council an annual fee which is inclusive of value-added tax, in the amount prescribed by the Council from time to time, and as notified by the Council in the Gazette and on the Council's, website [of R345 (inclusive of value-added tax)] for the issue to him or her of a Fidelity Fund certificate, such fee being payable on application for a Fidelity Fund certificate.

#### Amendment of Rule 4

### Rule 4: Annual Fees payable by all legal practitioners

- 4.1 Every [practising] legal practitioner who is admitted and enrolled in terms of section 24(1) of the Act as a legal practitioner shall pay an annual fee to the Council at such time as may from time to time be fixed by the Council. That fee (which is inclusive of value-added tax) shall be the amount prescribed by the Council from time to time, as notified by the Council in the Gazette and on the Council's website: Provided that in prescribing such annual fee, the Council may differentiate between legal practitioners according to their category of admission and enrollment in the case of all legal practitioners and the date of enrolment in the practising roll in the case of practising attorneys.
  - [4.1.1 in the case of a legal practitioner enrolled on the practising roll during the first two years of practise: R1 725; and
  - 4.1.2 in the case of a legal practitioner enrolled on the practising roll and who has been on the practising roll for more than two years: R4 025.]

### Amendment of Rule 5

# Rule 5: Fees payable in respect of examinations conducted by the Council

- 5.1 Every legal practitioner and every candidate legal practitioner entering any examination conducted by the Council or on behalf of the Council, or repeating any such examination, shall pay [the following] fees to the Council, which are inclusive of value-added tax in the amounts prescribed by the Council from time to time, and as notified by the Council in the Gazette and on the Council's, website in respect of the following:
  - 5.1.1 **[in respect of]** the examination referred to in section 26(1)(d) **[R345]** of the Act (candidate legal practitioners);
  - 5.1.2 **[in respect of]** the examination referred to in section 26(2) **[R345]**

of the Act (conveyancers);

5.1.3 **[in respect of]** the examination referred to in section 26(3) of the Act (notaries)."
