In a number of instances, there were positions in the Provincial Councils where there was only one nomination submitted and accepted. These candidates will automatically become members of the Provincial Council as the nominations are uncontested. Nominees for uncontested positions will not appear on the ballot papers when elections commence on 22 February 2022.
