1. Abovementioned acting appointments are only available from 03/04/2023 to 30/06/2023. Depending on the circumstances, the acting period may be extended at the recommendation of the Chief Magistrate.
2. Interested legal practitioners and/ or suitable qualified persons are invited to submit their applications to the Office of the Chief Magistrate via email to [RTerblanche@justice.gov.za](mailto:RTerblanche@justice.gov.za) or hand delivered to the Secretary of the Chief Magistrate, Mrs BS Mofokeng-Magagula, Office of the Chief Magistrate, First Floor, Office No 1.020, Kimberley Magistrates Court, corner of Knight and Stead Streets, Kimberley not later than 13/03/2023.
3. Requirements - An appropriate legal qualification and at least seven (7) years' post-university applicable legal experience. Knowledge and enhancing efficient and affective case flow management principles, elimination of case backlogs as well as being the holder of a driver's licence will be an advantage.
4. Interested legal practitioners and/or qualifying persons are invited to submit an application form (available at the Office of the Chief Magistrate, Kimberley and/ or Heads of Offices of all court houses) and all relevant documents included but not limited to the following documents should be attached:
  - (a) A certified copy of Identity Document
  - (b) Certified copies of all academic and professional qualifications
  - (c) An affidavit of assets and liabilities setting out specific amounts
  - (d) A complete curriculum vita with full particulars regarding all judicial experience
  - (e) Advocates, attorneys and prosecutors who apply for the acting post should together with their application documents, submit a recent [not older than 6 months] certificate of good standing from their respective controlling bodies and in instances of prosecutors from the National Prosecuting Authority.

4. Shortlisted candidates may be invited for a virtual interview.
5. The Chief Magistrate will submit an application for acting appointment of a suitable candidate (if any) to the Deputy Minister of Justice and Constitutional Development, in whose discretion the approval of an acting appointment as Magistrate is.
6. Should an applicant not receive any communication from the Office of the Chief Magistrate by 17/03/2023, he/she must consider his/her application as unsuccessful.
