## NOTICE TO LEGAL PRACTITIONERS

### INVITATION TO LEGAL PRACTITIONERS TO SERVE AS AN AGENT OF THE CURATOR BONIS WHERE THE LPC HAS BEEN APPOINTED AS SUCH IN TERMS OF SECTION 90(1)

Dear Legal Practitioners

The Legal Practice Council, invites directors/partners of the Legal Practices established in terms of section 34(1) and section 34(7) of the Legal practice Act 2014, as amended, to serve as agents of the curator *bonis* for the (9) Provincial Offices:

#### **REQUIREMENTS:**

**Legal Practitioners [The legal practitioner, OR the duly nominated and authorised partner of a partnership, OR the duly nominated and authorised director/member of an incorporated practice who/which is the applicant]:**

- Must have been practicing for an uninterrupted period of not less than (5) five years.
- Must be in good standing and in possession of the current Fidelity Fund Certificate [including all the other partners, directors, or members if applicable].
- Must not be the subject of any disciplinary proceedings.
- Must not be the subject of any interdict / suspension or striking off Court proceedings.
- Legal Practitioners who serve on the Legal Practice Council and Provincial Councils, are not eligible to serve as an agent of the curator *bonis*. *[During the process of either application, selection or appointment, OR during the period of service as panel legal practitioner, he/she must NOT be a member of - or a candidate standing for election to - the Legal Practice Council, a Provincial Council, the Legal Practitioners Fidelity Fund Board, OR any of the committees of the afore-listed structures.]*
- Applicants practising in partnership or as juristic entities will be required upon being appointed as an agent to submit proof of the partner(s)/director(s) consent thereto.

Legal Practitioners are required to submit their detailed resume and specify their area of expertise. The resume must be accompanied by the legal practice' profile.

Applications are to be submitted to the Provincial Office at which you intend to serve and addressed to the Director of that Province. kindly note that the agents will not be paid for the service rendered, but refund of disbursements.

**Duration for Panel of Agents:**

The duration for the panel of agents will be three (3) years.

The Council reserves the right to not make an appointment if it so deems necessary.
